

agreement is prepared and executed, acceptance of this tender shall constitute a binding contract between you and Railway Administration subject to modification, as may be mutually agreed to in terms of item No.3 of your tender. Please attend this office within 15 days for signing the agreement from the date of issue of acceptance letter.

The finalization of the contract is based on the satisfaction of the administration with regard to the physical fitness & turnout of the Supervisors and security guards who will be examined a committee consisting by the railway administration and reported. Therefore, you have to produce the supervisors & security guards before the committee for verification of their physical standards, knowledge in fire fighting, minimum educational qualifications, etc., on 16.08.2010 at NED. The list of security guards going to be deployed at the above stations with photographs may be submitted immediately, along with the verification report of antecedents by concerned police.
